FUND MANAGER'S COMMENTS, 28.02.2025

US Equity Markets

February brought significant volatility to US equity markets as President Donald Trump imposed new tariffs on the country's key trading partners, heightening investor concerns about a potential trade war. The newly announced 25% tariffs on imports from Mexico and Canada, along with an additional 10% duty on Chinese goods, are still in the process of being clarified, but their impending implementation has already triggered strong market reactions.

Until now, markets had largely assumed that Trump's previous tariff threats were mainly a negotiation tactic. However, the actual enforcement of these measures shook equity markets and triggered a broad sectoral rotation. The industrial and technology sectors were particularly affected, given their reliance on global supply chains.


The VIX, or "fear index," surged by nearly 25% in February, reflecting growing investor uncertainty and market nervousness. The S&P 500 index declined by 1.3% over the month, pressured by both trade tensions and stronger-than-expected labor market data, which could extend the Federal Reserve's period of elevated interest rates.

Technology Sector and NVIDIA's Performance

Highly anticipated quarterly earnings from NVIDIA (NVDA) met analyst expectations and remained strong. However, as market participants had already priced in the company's rapid growth, the results failed to deliver a major surprise. While the outlook remains optimistic, NVDA's stock has declined by approximately 3.5% yearto-date, reflecting elevated expectations and some profit-taking.

Meanwhile, large-scale investments and capital expenditures in the artificial intelligence (AI) sector have raised concerns among investors about the sustainability of AI infrastructure spending.
